Indiana University's law school in Indianapolis is named for Robert H. McKinney, a distinguished lawyer, businessman, and civic leader. For over 100 years, the law school has provided academic excellence and professional opportunities in the heart of Indiana's capital city. Located on the campus of Indiana University Purdue University Indianapolis, McKinney Law enjoys active collaboration with the IU Schools of Medicine, Dentistry, Nursing, Social Work, the Kelley School of Business, and the Fairbanks School of Public Health. The law school building, Lawrence W. Inlow Hall, is a state-of-the-art facility that enables the faculty to employ the latest technology and teaching methods. Inlow Hall houses modern classrooms, private study areas, and an unparalleled law library. The school is a short walk from the state's courts, the legislature, and major law firms, giving students the opportunity to observe the law in action and to gain practical experience as clerks and externs. IU McKinney is the only law school in the state offering both day and evening programs, as well as the cultural, recreational, and professional advantages of an urban setting. Put Law Into Practice



EXPERIENTIAL LEARNING is a critical component of modern legal education. At IU McKinney, you will have ample opportunity to gain hands-on legal experience. We offer seven live-client clinics, as well as an extensive array of externships and clerkships.

Live-Client Clinics

In the Civil Practice Clinic, you will represent real clients in a variety of cases including housing, divorce, child support, consumer, and administrative matters. In the Disability Clinic, you will interview, counsel, and provide administrative representation to clients with physical or mental disabilities in a range of complex matters before the Social Security Administration. In the Criminal Defense Clinic, you will represent clients in criminal cases in misdemeanors and lower-level felonies. There are additional clinical opportunities in the Immigration Law Clinic, the Appellate Practice Clinic, the Health and Human Rights Clinic, and the Wrongful Conviction Clinic. In all of the clinics, your faculty supervisors will be there to help and to oversee your work, but you will be doing the same things that practicing attorneys do every day.

Externships

We offer over 60 externships in state and local government, the courts, organizations such as the NCAA, non-profits such as the Sierra Club, and at businesses such as Eli Lilly and Company. You can put your legal education to work and gain valuable résumé-building experience even before you graduate.

Moot Court and Other Opportunities

The school also offers an extensive moot court program, a client counseling program, *pro bono* program and three law reviews: INDIANA LAW REVIEW, INDIANA INTERNATIONAL AND COMPARATIVE LAW REVIEW, and INDIANA HEALTH LAW REVIEW.

Skills Training

Even before legal employers began to demand that graduates be practice-ready, we offered classes in interviewing and counseling, mediation, and trial and appellate advocacy. Many of our doctrinal courses integrate litigation or transactional practice skills. In response to market feedback, we continue to develop our skills training and take advantage of the latest innovative teaching pedagogies. THE WILLIAM S. AND CHRISTINE S. HALL CENTER FOR LAW AND HEALTH is one of the top health law programs in the nation. The center serves as a preeminent information resource on health law issues for the bar, government and health care community. Through the center, you may pursue a Certificate in health law and participate in the Indiana Health Law Review, as well as the Health Law Society.



THE PROGRAM ON LAW AND STATE GOVERNMENT (PLSG) enriches the dialogue between the academic legal community and state government policy makers. The program offers externships with more than 50 government offices and also sponsors a mediation course that qualifies students to become registered civil mediators. Additionally, the program sponsors fellowships that allow students to host an academic event and write a publishable academic paper on critical legal or regulatory issues pertinent to state government.



THE ENVIRONMENTAL AND NATURAL RESOURCES LAW PROGRAM (ENR) offers a path to expertise in a growing area of legal practice that addresses complex issues of resource development and conservation, pollution control, energy and transportation policy, environmental justice, and other related subjects. If you are interested in becoming an environmental or a natural resources lawyer, the ENR Certificate can help you achieve your goals.



THE CENTER FOR INTELLECTUAL PROPERTY LAW AND INNOVATION is active in all areas of IP law, including patents, copyrights, trademarks, and the right of publicity, with a focus on issues of importance to the life sciences. In addition to an IP Certificate, externships and networking opportunities, the IP Center also works closely with student organizations such as the Intellectual Property Law Student Association; Fashion, Art and Design Law Society; and the Sports & Entertainment Law Society.



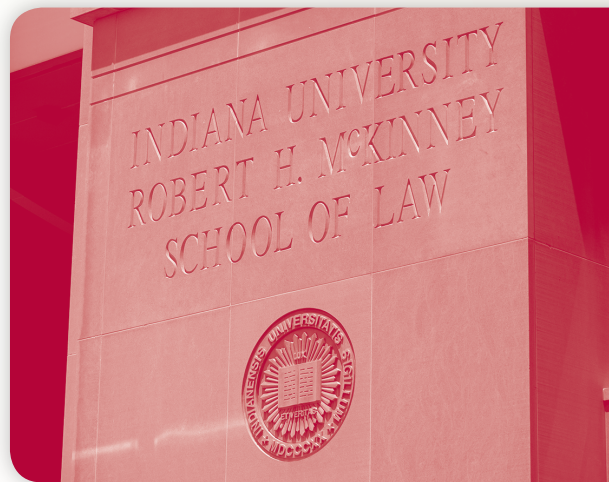

This center organizes a variety of events including annual conferences, while the **INDIANA INTERNATIONAL AND COMPARATIVE LAW REVIEW** provides students with in-depth research opportunities. Students interested in a career in international crisis management may take advantage of the simulated crisis training offered by our **GLOBAL CRISIS LEADERSHIP FORUM**.



Our **PROGRAM IN INTERNATIONAL HUMAN RIGHTS LAW** places students in internships with human rights organizations in locations from Argentina to Zimbabwe and holds Special Consultative Status with the United Nations, allowing our students to contribute to human rights law on a global scale.



The school's **JOINT CENTER FOR ASIAN LAW STUDIES** is a collaboration with Renmin University of China Law School—the top law school in China. The center offers the Chinese Law Summer Program, the annual International Law Student Forum, and the Annual Sino-U.S. Law Conference, all in Beijing. It also sponsors the Summer Program in U.S. Law which welcomes Chinese students and professors from Sun Yat-sen University Law School.

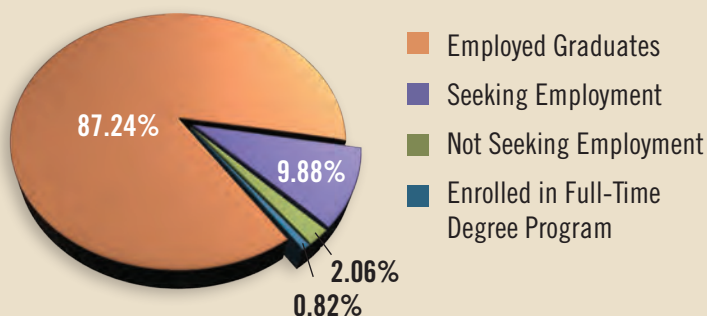

In addition to the required courses, we typically offer **OVER 120 ELECTIVES EVERY YEAR**. Course areas include Administrative Law, Criminal Law, Family Law, Legal Perspectives, Litigation and Dispute Resolution, Labor and Employment Law, Real Estate, State Government, Tax and Estate Planning, Torts and Personal Injury, as well as many others.

You will also find unique course offerings such as:

OVER 60 EXTERNSHIPS in state government, business and non-profit positions including the Office of the Governor, the NCAA, Eli Lilly and Company, and the Sierra Club to name a few.

SPORTS LAW, taught by Dean Gary R. Roberts, a nationally-recognized expert in sports law, who has published several articles and book chapters on antitrust, labor, and other issues in the sports industry, and co-authored the leading casebook on sports law. He has served as president of the Sports Lawyers Association and as chairman of the AALS Sports Law Section. He served as the on-air legal analyst for the NFL Network with respect to the labor dispute that threatened the 2011 professional football season.

SEMINAR IN COMPARATIVE NATIONAL SECURITY LAW, which includes an opportunity for you to participate in a biennial counter-terrorism simulation exercise that brings together students, professors and experts in public safety and international security from around the world in a one-day event that allows you to play the roles of a leader in a crisis situation. You'll hone your reasoning, negotiation and communication skills in a high pressure environment.

CYBER CRIME, a cutting-edge course on an area of increasing importance and complexity. This seminar explores the legal and policy issues judges, legislators, prosecutors and defense counsel confront as they respond to the recent explosion in computer-related crime. In particular, you will consider how conduct in cyberspace challenges traditional approaches to the investigation, prosecution and defense of criminal conduct in physical space.

NATURAL RESOURCES LAW. This course surveys laws and institutions designed to conserve, protect, and manage the use of natural resources. It provides an overview of management challenges and mechanisms, and reviews the history, structure, and constitutional basis of federal authority over natural resources and their management. It also examines institutions and actors that are relevant to natural resource management and planning, as well as basic obligations of the government to review the potential environmental impact of its decisions under the National Environmental Policy Act.

Cynthia M. Adams

Clinical Professor of Law



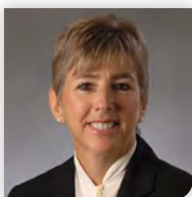
Before joining IU McKinney Law's top-ranked Legal Analysis Research and Communication (LARC) program,

Cynthia Adams, '83, practiced law with the Indianapolis firm of Stark Doninger Mernitz and Smith, focusing on general business, acquisitions and mergers, commercial loans, and trusts and estates. Professor Adams co-authored a book entitled *The International Lawyer's Guide to Legal Analysis and Communication in the United States*, (Aspen Publishers, Inc., 2008). She is also co-author of the forthcoming book, *Drafting U.S. International Contracts in Legal English*, (Aspen Publishers, Inc., 2013). She teaches courses in transactional skills, deal-making, and negotiations. Her principal areas of research include domestic and international business transactions; international business mediation and arbitration.

Jennifer A. Drobac

Professor of Law



Professor Drobac's recent research explores the nature of legal capacity and consent. Relying on neuroscience discoveries concerning

adolescent “developing capacity” and geriatric “declining capacity,” Drobac analyzes how the law of consent currently works to disadvantage vulnerable constituents. In response to a variety of problems including sexual harassment, predatory lending, and internet contracting, Drobac examines how more powerful, better informed actors exploit choice and consent to insulate themselves from legal responsibility and liability. She suggests that systemic legal reform would help teens, the elderly, minorities, and other vulnerable populations and could make legal interacts more efficient generally.

Before entering the academy, Professor Drobac clerked for the Honorable Barefoot Sanders, U.S. District Court for the Northern District of Texas and practiced law in California, focusing on employment law issues and litigation.

“I teach because I love connecting with my students to explore new legal concepts that address real world problems or that promise to facilitate human advancement,” Drobac says. “At IU McKinney Law, we work in the state capital, at the crossroads of America, and beyond—my students are eager to meet the

challenges apparent here and I am enriched by helping them in these demanding times. Collegial and creative collaborations, like those forged here, are what will guide our nation, business, and innovation into the future.”

Fran Quigley

Clinical Professor of Law



Professor Fran Quigley, who graduated from IU McKinney in 1987, teaches and directs the Health and Human Rights Clinic,

where students advocate on domestic and international human rights issues and directly represent clients in cases including worker rights and access to public benefits. Quigley regularly writes mass media and academic journal articles on social justice issues, with a particular focus on human rights in Haiti and the rights of low-income workers in the U.S. Quigley has published *Walking Together, Walking Far: How a U.S. and African Medical School Partnership Is Winning the Fight Against the HIV/AIDS Pandemic* (Indiana University Press, 2009) and has recently completed a book, *Victory for the People: How Human Rights Can Save Haiti*. In addition to teaching, Professor Quigley has also served as the executive director of ACLU of Indiana and as a staff attorney with Indiana Legal Services.

Quigley says, “I love teaching at IU McKinney for two reasons: One, we are embedded in an urban community that presents an enormous number of opportunities for our students to use their skills to promote justice for all. And two, I love teaching here because we have a faculty and student body that actively embrace the international community and fully engage in the mission of making the world a better place.”

Gerard N. Magliocca

*Samuel R. Rosen Professor of Law
Associate Dean for Research*



Gerard N. Magliocca, the Samuel R. Rosen Professor of Law, is the author of three books and over twenty articles on

constitutional law and intellectual property. Professor Magliocca joined the faculty after working at Covington and Burling and clerking for Judge Guido Calabresi on the United States Court of Appeals for the Second Circuit. Professor Magliocca's book *Andrew Jackson: The Rise and Fall of Generational Regimes* was the subject of an hour-long program on C-Span's "Book TV." In 2008, he held the Fulbright-Dow Distinguished Research Chair of the Roosevelt Study Center in Middelburg, The Netherlands. Professor Magliocca is currently putting the finishing touches on his biography of Congressman John Bingham, the author of the Equal Protection Clause in the 14th Amendment. He is also an active blogger on Concurring Opinions and Balkinization. He teaches in the areas of torts, constitutional law, intellectual property, legal history, and admiralty law.

"I want my students to be as excited about the law as I am," says Magliocca.

Vice Dean and Professor of Law



Prof Page primarily teaches and publishes in the areas of corporations, mergers & acquisitions, securities regulation,

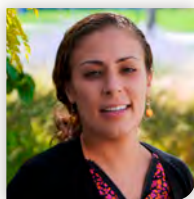
and corporate governance. His scholarly work has been cited by US courts, including the Supreme Court and four state supreme courts. Prior to arriving at McKinney, he worked at the law firm of Sullivan & Cromwell in both

their London and Los Angeles offices. From 1990-94, he was a diplomat in the Canadian Department of Foreign Affairs, serving in Thailand, Laos, and Burma. He is currently researching and writing about the emerging area of social enterprises, including the recently introduced benefit corporations, low profit limited liability companies, and socially responsible corporations. These hybrid businesses are intended to both make a profit and actively pursue a social mission, unlike traditional companies or charities. Whether these businesses will really transform the world remains an open question, but the legal issues they raise are fascinating and immediate.

Before joining the IU McKinney Law faculty, Lahny Silva was the William H. Hastie Fellow at the University of

Wisconsin Law School in Madison where she served as teaching assistant for Constitutional Law, Trial Advocacy and Civil Procedure. In 2010 she was a legislative appointee for the State of Wisconsin Special Committee on Review of Records Access of Circuit Court Documents. Previously, she worked as an attorney for Greater Hartford Legal Aid and as a law clerk for the Office of the Corporation Counsel. She worked on Connecticut's Statewide Legal Services Initiative, "Ban the Box," and served as Chair of the Diversity Committee while at the University of

Connecticut School of Law, where she was also involved in the Black Law Student Association (BLSA), the Public Interest Law Group, and Equal Justice Works. Her areas of interest include criminal law, criminal procedure, constitutional law, torts and evidence.

Carlton M. Waterhouse

Associate Professor of Law



Professor Waterhouse is nationally recognized for his work on environmental justice and is known

internationally for his research and writing on reparations for historic injustices and state human rights violations. His views have been published in the *Wall Street Journal* online and his articles have appeared in numerous prestigious law journals. He began his career as an attorney with the U.S. Environmental Protection Agency where he served in the Office of Regional Counsel in Atlanta, GA and the Office of General Counsel in Washington, D.C. At the EPA, he served as the chief counsel for the agency in several significant cases and as a national and regional expert on environmental justice, earning three of the Agency's prestigious national awards. In addition to teaching courses on property law, administrative law, and environmental law, he teaches seminars on environmental justice and on political reconciliation and reparations that address the unique relationship between law and social ethics.

"I really love teaching law," says Waterhouse. "It is a great opportunity to explore the ideas and principles that govern our society and our lives with students who are open and eager to learn. Here at IU McKinney, bright and hardworking students come prepared to learn and to test what they have learned in a lively and challenging environment."

Pamela Carter, '84

*President, Cummins Distribution Business
Former Indiana Attorney General*

Pamela Carter entered the record books when she became the first female African American state attorney general in United States history in 1993, as well as the first female attorney general for the state of Indiana. She remembers her days at the Indiana Attorney General's office with enthusiasm. **"We had a fabulous office. We won more U.S. Supreme Court cases and more Best Brief Awards than any other attorney general's office in the nation,"** she says. Her 15-year career as a social worker, along with her law degree, had helped her land her first job in the public sector, which was as Deputy Chief of Staff and Executive Assistant for Health Policy and Human Services for then-Indiana Governor Evan Bayh. Turning her talents to international business, she has held a number of positions in this country and abroad and is now the president of Cummins Distribution.



John S. Pistole, '81

*Administrator, U.S. Transportation Security Administration (TSA)
Former Deputy Director, Federal Bureau of Investigation (FBI)*

John S. Pistole was confirmed as the TSA's Administrator in July 2010. In that role, he oversees management of a 61,000-strong workforce, the security operations of more than 450 federalized airports, the Federal Air Marshal Service, and the security for highways, railroads, ports, mass transit systems, and pipelines. Before that, as deputy director of the FBI, Pistole was the chief operating officer of the bureau, overseeing a \$7 billion annual budget and 31,000 employees dedicated to defending the nation against terrorist and foreign intelligence threats, enforcing the criminal laws of the U.S., and providing criminal justice services to other agencies and partners. Pistole practiced law for two years after law school before joining the bureau, where he specialized in white-collar crime, organized crime, and, following 9/11, counterterrorism and counterintelligence. **"The academic and analytic rigor of my law school education has been critical to assessing and addressing issues....Being a lawyer is a distinct benefit because I pick up on subtleties and nuances that are crucial in my work."**



Hon. Jane Magnus-Stinson, '83

United States District Court, Southern District of Indiana

Before becoming a federal judge, the Honorable Jane Magnus-Stinson presided for 12 years over a criminal court. Nearly a decade of litigation, four years as Indiana Governor Evan Bayh's legal counsel, and her time on the Marion County Superior Court criminal bench have prepared her to understand all sides of each case that comes before her. At the law school's 2012 orientation, Judge Magnus-Stinson said she owes a great deal to the law school, and credits it with planting the seed for public service. **"In one of the many ways that makes it special, this law school provides countless opportunities for *pro bono* service and clinical involvement through which you, as the newest of the new, can put your good minds and boundless energy to work for the betterment of the community."**



Lacy Johnson, '81

Partner, Ice Miller, LLP

As a partner in the Indianapolis firm Ice Miller, LLP, Lacy Johnson has a busy law practice, but he's just as busy outside the office. Johnson has served on the board for the Indianapolis Airport Authority, the U.S. Congressional Black Caucus Political Education and Leadership Institute, Indiana Black Expo, Conner Prairie, Simon Youth Foundation, Indianapolis Downtown, Inc., the Oaks Academy, American Pianists Association, and the Indiana Museum of African American History. Of his civic work he says, **"It's my way of putting back some of what I've been given. I'm living the American dream."** Educated in public schools in Indianapolis, Johnson went on to earn a bachelor's degree in political science and industrial management from Purdue University. He joined the Indiana State Police before starting law school. He served for many years in the U.S. Navy Reserves, retiring with the rank of lieutenant colonel. He worked in government relations, as a director of security for the Indiana State Lottery, and as a state police deputy superintendent before joining Ice Miller in 1993. **"I've been touched by some fantastic people,"** Johnson says. **"What you can do with that is pass it on."**

Scholarships

Application Checklist

- ☐ **APPLICANTS MUST HAVE A COMPLETED BACHELOR'S DEGREE** from an accredited institution to be eligible for admission before they begin their 1st year of the JD program.
 - There is a limited exception to this rule if the applicant meets ALL of the following criteria. If so, he or she may be admitted as a candidate for the Bachelor of Law (LL.B.).
 - The applicant is at least 30 years old.
 - The applicant has completed at least 3/4 of the credit hours required for a bachelor's degree with a GPA of 3.3 or higher.
 - The applicant has not been enrolled in an academic program for at least 5 years.
 - The applicant scored in the 75th percentile or higher on the LSAT.
- ☐ **LSAT SCORE** – All applicants must take the Law School Admissions Test. McKinney Law considers the highest of multiple LSAT scores in the admissions process. In addition, LSAT scores are valid for 3 years for admissions purposes at our school.
- ☐ **CAS REPORT** – Applicants must register for Credential Assembly Service (CAS) through LSAC. Registration for both CAS and the LSAT can be done at www.lsac.org.
 - Applicants will have all of their undergraduate and graduate transcripts forwarded from the issuing institutions to LSAC. Applicants' recommenders will forward their letters of recommendation to LSAC.
 - The Office of Admissions will request a CAS report after we receive an applicant's application. The CAS report contains the applicant's LSAT score(s), summary of academic work, copies of LSAT writing samples, copies of transcripts, and up to 3 letters of recommendation. This will become part of the applicant's file.
- ☐ **PERSONAL STATEMENT** – Applicants must submit a statement written and composed by the applicant. This is the applicant's opportunity to provide more information about the applicant and any other relevant information that he or she would like the Admissions Committee to consider in the decision making process. This may include the reasons for seeking a legal education.



- ☐ **LETTERS OF RECOMMENDATION** – We require 2 letters of recommendation but highly recommend three. We prefer the letters to be submitted through CAS service. Recommendations from professors or employers may be helpful if the recommender can make candid evaluations of the applicant's academic performance, work habits, analytical ability, and character.
- ☐ **CHARACTER AND FITNESS EXPLANATIONS** – Each state sets minimum standards of character and fitness to practice law. For this reason applicants must divulge all arrests, citations, tickets, and any charges either as an adult or juvenile, regardless of final disposition. (This includes incidents that have been expunged from the applicant's record.) All character and fitness issues must include a detailed statement of explanation which includes facts and disposition of the issues.

NOTE: You must maintain the accuracy of these statements throughout the admissions cycle and if offered admission, during your tenure as a student. Prior to being certified to sit for the Bar, Bar Examiners may review the information that is contained in the law school admission application during the character and fitness investigation. Failure to disclose or maintain the accuracy of these statements may result in not being certified to sit for the Bar. It may also result in the revocation of your admission and/or law degree.

- ☐ **RESUME** – An applicant may submit a resume describing his or her academic, extracurricular, volunteer work, and professional activities.
- ☐ **OPTIONAL STATEMENTS** – These statements may be submitted if there are parts of the application that needs to be expanded upon, needs emphasis or clarification.
- ☐ **DIVERSITY STATEMENTS** – This is another optional statement applicants may submit if the they would like the admissions committee to consider how the applicant's experiences will contribute to the richness of the classroom environment. This can include but are not limited to experiences that resulted from overcoming hardships or obstacles, socioeconomic status, educationally disadvantaged, racial, cultural, sexual orientation, disability status, and/or age.
